Campaign Goals

INFORM financial advisers and Ohio families that opioid misuse is common and poses a massive financial risk for the families affected by it.

EDUCATE on the signs of opioid use disorder and that accessible, nearby treatment options are available.

ENGAGE with key audiences to ensure Ohioans are aware of the various ways to pay for treatment and that a financial adviser can help navigate the cost.

Ohio is 1 of 5 states with the highest rates of opioid overdose deaths in the nation.³

The most recent CDC data shows opioid use disorder and opioid overdose deaths cost Ohio more than \$72.58 billion — more than any other state in the nation.⁴ [Tweet this fact.](#)



How Financial Advisers Can Help

Thirty-nine percent of people did not seek treatment because they couldn't afford it or didn't have health insurance.⁷

The prevalence of addiction in Ohio would suggest that many financial advisers are **missing the signs** that it is affecting their clients. Nearly two-thirds of financial advisers in Ohio reported that **none of their clients were impacted by an opioid addiction.**⁸

A trusted financial adviser can help **mitigate financial risk** by educating themselves and their clients about the **signs of addiction and available treatment resources.**






